<u>2023-2024 Parent/Player Conduct~</u> <u>Disclosures and Payment Agreement</u>

General Player Conduct:

- Players will be expected to make both athletics/academics a priority in their lives.
- Players are expected to manage their time accordingly to attend and be on time to practices/tournaments and other related functions with the team.
- Players will treat ALL coaches, parents, tournament staff, and directors with courtesy and respect at all times.
- Players are expected to exhibit a positive attitude. Team unity should take precedence over individual needs. An attitude that is not conducive to team unity will not be tolerated.
- Alcohol, tobacco and drugs will NOT be tolerated. If abused, an automatic suspension will be issued.

General Parent Conduct:

- Parents are encouraged/expected to be active and involved with the team; as well as supportive of each player and the entire team.
- Parents are expected to be supportive of the coach at alltimes.
- Communication should be directed from coach to athlete to parent for all issues involving the player and the team. The director will only be involved as needed.
- Parents are expected to refrain from discussion of playing time issues or other issues at tournaments or during normal practice times. The coach is responsible for explaining all issues and decisions to that athlete who approaches and asks for clarification in a disciplined manner, and ONLY at an appropriate time. Parents should seek information from their athletes first. If deeper explanation is needed, parents should approach the coach OUTSIDE of normal practice time or tournaments. The coach is expected to NOT entertain the above mentioned conversations before, during, or after practice time, nor during tournament/event, including at the playing site, during the time of the event, nor travel time.

Insurance Disclosure: USA Volleyball covers my daughter only during practice and tournament play.

Fees Disclosure: Total expenses include uniforms, gym rental, coaches salary/expenses, tournament fees, balls/equipment, and administration fees to AEV.

Full Payment Responsibility: I understand if my daughter incurs an injury or decides not to play at anytime during the season, I will remain liable for the total club season dues.

Terms of Payment: I agree to pay a non-refundable deposit of \$500 to AEV upon accepting my daughter's invitation to play on the team. (\$500 due November 1st 2023). The remaining balance will be due in 4 payments (by pre-dated checks or credit card info) on Nov 15, 2023, Dec 15, 2023, Jan 15, 2024 and Feb 15, 2024. I may pay in full and receive a 5% discount on my total season cost. I understand and agree to the payment terms. I understand if I default my payment obligation, my daughter will not be allowed to attend practice or tournament play. I will also be held liable for any/all attorney, court and administrative costs associated with the collection of unpaid fees.
